**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Suruhanjaya Pelantikan Kehakiman (Proses Pemilihan dan Kaedah Pelantikan Hakim-Hakim Mahkamah Atasan) (Pindaan) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 30 Mac 2021.

**Pindaan peraturan 8**

2. Peraturan-Peraturan Suruhanjaya Pelantikan Kehakiman (Proses Pemilihan dan Kaedah Pelantikan Hakim-Hakim Mahkamah Atasan) 2009 [*P.U. (A) 209/2009*] dipinda dalam subperaturan 8(1)—

(a) dalam perenggan (c), dengan memotong perkataan “dan” di hujung perenggan itu;

(b) dalam perenggan (d), dengan menggantikan noktah di hujung perenggan itu dengan perkataan “; dan”; dan

(c) dengan memasukkan selepas perenggan (d) perenggan yang berikut:

“(e) Lembaga Hasil Dalam Negeri Malaysia.”

JUDICIAL APPOINTMENTS COMMISSION  
(SELECTION PROCESS AND METHOD OF APPOINTMENT OF JUDGES OF THE  
SUPERIOR COURTS) (AMENDMENT) REGULATIONS 2021

IN exercise of the powers conferred by section 30 of the Judicial Appointments Commission Act 2009 [Act 695], the Prime Minister, on the recommendation of the Commission, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Judicial Appointments Commission (Selection Process and Method of Appointment of Judges of the Superior Courts) (Amendment) Regulations 2021**.

(2) These Regulations come into operation on 30 March 2021.

**Amendment of regulation 8**

2. The Judicial Appointments Commission (Selection Process and Method of Appointment of Judges of the Superior Courts) Regulations 2009 [P.U. (A) 209/2009] are amended in subregulation 8(1)—

(a) in paragraph (c), by deleting the word “and” at the end of the paragraph;

(b) in paragraph (d), by substituting for the full stop at the end of the paragraph the words “; and”; and

(c) by inserting after paragraph (d) the following paragraph:

“(e) Inland Revenue Board of Malaysia.”.
